The Health Food Additive bills are all in committee and are being worked on by the committee. Whether the committee will report out the Delaney Bill with a do pass or a combination of all the bills, no one is in a position to say at this time. Those of you who have written to your Congressman or to Congressman Delaney have done a good job and whatever comes out will be the better for your having written. We cannot always get all that we desire, but working for what we desire causes the result to be more in keeping with what we feel such legislation should be.

The petitions which so many of the N.H.F. chapters and members have been getting signed have had a very good effect, because in getting signatures the one with the petition has to do an educating job on Food Additives to get each signature.

The Washington office suggests that in each county of the nation during the Election Campaign, N.H.F. Chapters and other organizaions interested in the health field hold joint meetings and invite their state and national legislators (Continued on Page 10)

#### National Health Federation's Presentation to California Senate Interim Committee

By FRED J. HART

Senator Thompson, Mr. Connelly and distinguished members of the Committee, I count it a rare privilege to have been invited to appear before you and present the case of the National Health Federation, as such may be connected with the purposes for which this Committee was created.

I am very proud indeed of the action of the Senate when in its deliberate judgment it decided that new type and far reaching legislation, such as the Weinberger Bill appeared to be, called for an honest searching for the truth and appointed such a Committee for that purpose.

I say I am proud because along with Vince Garrod of Santa Clara County and six other agricultural leaders it was my privilege to have had a large part to do with the origination and adoption of the Federal Plan of Apportionment as we have it in California today, whereby the Senate represents the counties while the Assembly is apportioned on the basis of population thus representing the masses.

I am very pleased at the fair and hon-

est conduct of this Committee to date as well as the willingness of the Committee to hear both sides of the matters in question. May I assure you that I hold no animosity toward those who disagree with what I believe and know in my own mind to be the truth.

I shall be as frank and honest in my answers to the Committee's questions as I know how to be and I shall endeavor during this presentation to treat the Committee as I would like a witness to treat me if I were a member of the Committee, for I am confident the Committee members will accord me the same courtesy and consideration as they would desire to have accorded to them if they were a witness in my stead.

#### Why National Health Federation?

\*At this point I would like to tell you briefly how the National Health Federation came to be organized. I think you will then better understand our plan of operation and objective. Our special concern as an organization is with our precious heritage of freedom of choice as

guaranteed by the Constitution. Our forefathers set up a limited form of government under the Constitution, with maximum freedom of choice left to the individual citizen. Immigrants flocked to America in search of freedom of opportunity. Most European countries were suffering from too much government. There were so many restrictions the farmer had a hard time farming; the businessman found it difficult to carry on trade; and the manufacturer was hampered by governmental red tape and restrictions. America was a land of opportunity where a man could be free to enjoy the fruits of his own labor and good judgment. Uncounted millions of immigrants thronged to America to escape the heavy oppressive hand of their own governments. Here in America where government was limited to its proper funtion of protecting life and property, we have the highest standard of living in the world. What a man may achieve here is limited only by his ability and ambition. Because we are free we have prospered. The United States is one of the few countries in the world which has to limit the number of immigrants. Many countries must maintain a powerful border guard to prevent their citizens from leaving their oppressive governments.

But in recent years our government has been reaching far beyond its proper function of protecting life and property. Today our government is expanding at a fearful rate, taking more and more of our income to support itself, and taking more and more choices away from its citizens. Our basic freedoms are being whittled away a choice at a time.

In the field of health, governmental bureaucracy has been whittling away at our basic freedom and God-given right to decide for ourselves what substances we shall take into our bodies and how we shall treat our bodies. That is one of the basic reasons why the National Health Federation was organized. Our members are individuals from every occupation and profession. We are united in our common concern for the spirit of freedom and fair play.

#### What N.H.F. Is

The National Health Federation is a non-profit, non-membership liability organization and was incorporated to represent, protect, and promote the best interests of the sick of the Nation, and those progressive doctors regardless of classification whose first interest in life is the healing of their patients; and to that end are courageous enough to use any harmless remedy, method or modality which their experience indicates as efficacious. And ...

To carry on the investigation, correlation, protection, and promotion of progressive research, theories, methods, products, modalities, and activities in all branches of the Healing Art; and to strive vigorously against any or all trends or movements which would deny freedom of choice on the part of the doctor and the patient, or establish a monopoly in the broad field of healing and research connected therewith.

The Constitution of the United States guarantees Freedom of Speech, Freedom of the Press, and Freedom of Religion. It implies Freedom of Health. But, we

## Andrew Conway Ivy, M.D.

An Introduction

false or superficial evidence."

The compulsions within the man who spoke these words are the same which have caused him to hold fast to principle, to remain incorruptible under the unremitting pressures of the ruling clique of the world's most powerful medical organization — and one in which he occupied a top spot until he refused to become party to a compromise of moral and ethical issues—the American Medical Association.

Author of the statement is Dr. Andrew Conway Ivy, world-famous physiologist, doctor of medicine, scientist. A man who has earned the respect and admiration of his professional colleagues, and who deserves the eternal gratitude of the unknown millions.

He is the man, chosen in 1947 as representative of world medicine at the Nuremberg Trials of doctors indicted for cruel and inhuman treatment of prisoners of war on the pretext that medical knowledge would be furthered. His role at the trials: to lay down the code under which nations will be guided in the future as relating to medical-ethical, scientific, and medical-legal conduct. (It is well to remember, as you read this story, that this is the stature of the man Ivy, whom certain men within his profession have sought to brand as a fraud, a quack, a cheap opportunist.)

This is the man who was awarded in 1953 the Pope Pius XIII citation for great services to humanity — a nominee

"I don't want the truth buried under of the Most Rev. Bernard J. Sheil, D.D., Auxiliary Bishop, Chicago, founder of the Catholic Youth Organization. Dr. Ivy happens to be a Methodist.

> This is the man who was presented with a Presidential Citation for his contribution to the war effort at the close of World War II; the man who holds degrees of medical doctor, doctor of philosophy, doctor of science as well as several honorary law degrees. He has taught more than 5,000 students; had an active part in preparation of more than 1,300 medical projects written for scientific journals; co-authored a classic volume on peptic ulcer; discovered most of the body's hormones; crusaded against the quota system (limiting the number of medical students on the basis of race and religion); launched research- projects culminating in an improved method of artificial respiration; held the world's first symposium on medical problems confronting the human being when he attempts to reach the stars; pushed for broader education for medics.

> He's a life member of the American College of Physicians; held membership on 10 research committees; as director, organized the Naval Medical Research Institute in Bethesda, Md., during World War 2; is past President of American Physiological Society; past president of American Gastro Enterologico Association: former chairman of the Section on Pathology and Physiology of American Medical Association; former mmeber of the Council on Physical Medicine and

Rehabilitation of the AMA; holder of the distinguished service medal from the American College of Physical Therapy; director-at-large (1947-51) of the American Cancer Society; first executive director of the National Advisory Council whose function was advising the National Institute on how to spend money appropriated by Congress for research.

This, then, is the pedigree. And what follows, in certain instances, will "make your hair curl" — that is, if you're an ordinary red-blooded American who believes in fair play, who believes that human beings are more important than dollars. But let the facts speak for themselves!

Dr. Ivy and his associate, Dr. Stevan Durovic, 53-year-old discoverer of the anticancer agent Krebiozen, spent a night and day in San Francisco where Ivy testified in opposition to a state cancer commission during a hearing before the California Senate Committee on Public Health. Your editor was privileged to spend several hours in company with the two scientists, for the purpose of passing on to HERALD OF HEALTH readers salient facts in connection with the dramatic story of Krebiozen, as well as the almost unbelievable events which have impeded its acceptance in conventional medical quarters.

This article is a composite of interviews with Dr. Ivy, excerpts of his testimony before the Senate committee, and a brief summary of the just-published "A Matter of Life or Death," written by Medical Writer Herbert Bailey, author of "Krebiozen — Key to Cancer?" The

book (\$4.95, published by G. P. Putnam's Sons, New York) is must reading for every person looking for information about the control of cancer. It should be read by every doctor, every school teacher, every clergyman, every editor, every holder of public office — and, yes — by every citizen who wants to be informed and who believes he has a stake in the preservation of personal liberty and intellectual freedom.

Doctor Andrew Conway Ivy appeared on 7 May 1958 to testify before the Senate Interim Committee on Public Health Hearings to Study and Analyze the Facts Concerned with Fraudulent, Dangerous and Deceptive Practices in the Field and Treatment of Disease. With Senator John F. Thompson as chairman, this committee is concerned specifically with determining the possible needs for special legislation defining the field of cancer treatment in California. The committee was formed to study the questions raised by the recently defeated Assembly Bill No. 2359, notoriously known as the Weinberger Cancer Board Bill and proposed by one Caspar Weinberger, recently defeated in the California primary for nomination as Republican candidate for Attorney General.

Assembly Bill No. 2359 proposed the establishment of a political board to evaluate various forms of cancer therapy falling outside the province of surgery and radiation. The bill was sponsored by the American Cancer Society and the California Medical Association. Since both of these organizations had publicly gone on record as condemning any form of cancer therapy except surgery and radiation, the practical intent of this bill was to limit by legislative fiat cancer therapy in California to surgery and radiation. Influenced by an outraged public, the members of the California Senate killed this bill in committee last vear. and the politically knowlegdeable have attributed the political defeat of its

author, Caspar Weinberger, to this proposed legislation.

In qualifying himself as an expert, Doctor Ivy stated: "I was the represent ative at the Nuremberg trials of the doctors concerned with committing medical atrocities. I was the expert there on the subject of medical science, medical ethics and medical jurisprudence. I represented world medicine there. I was selected by the Secretary of War, the Secretary of State, and on the recommendation from the Board of Trustees of the American Medical Association . . . so I'm competent in the field of medical ethics."

In opposing the proposed limitations on the freedom of choice of doctor and treatment, Ivy continuel: "If these persons are licensed to practice medicine and . . . use something not on the approved list, they would lose their license to practice medicine in the State of California . . . I'm against such regimentation in the field of the treatment of cancer patients, or in the field of any other treatment . . "

Later in his testimony, Ivy reiterated and enlarged upon his statement: "Any committee with such authoritative power as spelled out there (proposed cancer legislation) can, of course, in the course of time, be subject to corruption. It is a matter of history that any group that is set up with powers which are not directly subject to the electoral body is sooner or later subject to corruption. That is true of political organizations as well as

religious organizations and medical organizations."

Questioning the possibility of corruptibility in such organizations, Chairman Thompson queried: "Isn't 'corruption' rather a strong word? Wouldn't you sooner say 'prejudice'?"

"No, I wouldn't think so," replied Ivy. Economics of Cancer Therapy. After reviewing in the course of the hearing the possible motivation of avarice on the part of proponents of forms of cancer therapy exclusive of surgery and radiation, the committee obtained the following general summary through Ivy's direct testimony: "(Cancer patients) won't take the word of the D.O. or M.D. that nothing can be done for them. They look for the last straw . . . " For surgery and/or radiation, most cancer patients, Ivy pointed out, "have spent all the way from \$5,000 up to \$100,000 before they have reached this hopeless stage, and then are abandoned and written off, and that is a tragic situation insofar as our management of terminal cancer patients in our country is today."

Testifying on the cost of Krebiozen, an agent for cancer that Ivy contends deserves scientific study, he pointed out: 'No avarice was manifested, because it (Krebiozen) was all given away, and contributions were not accepted up until about three years ago, when we reached the bottom of the barrel of our supply of money, and then we asked the patients, which is entirely legal and under the regulations of the Federal Food and Drug and Cosmetic Act, to contribute on the basis of their ability to contribute towards the cost of production and distribution of Krebiozen. Since then about

sixty per cent of our patients have been unable to contribute anything, and I presume that about one per cent of the patients are able to contribute the full cost. Where is the fraud? Where is the avarice?"

(Although not brought out in the present hearing because of the failure of Mr. Harry Hoxsey to appear before the committee, it is established that the maximum cost of the Hoxsey treatment is \$460, though those unable to pay receive it for nothing.)

Popular Clamor for Medical Therapy of Cancer. Despite the millions of dollars of publicly donated funds spent by such organizations as the American Cancer Society to propagandize the alleged virtues of surgery and radiation in cancer and to condemn any other forms of cancer therapy, there is a popular clamor and even insistence for these other forms of therapy. This was manifest by the fact that the Weinberger Cancer Board Bill when before the California legislature drew more mail from the public than all other legislative proposals combined and the majority of the letters opposed any legislative attempt, however adroit, to restrict therapy in California to surgery and or radiation.

Discussing this phenomenon, Ivy pointed out: "Then we have a group of patients which have to be recognized. They consist of those who refuse surgery, x-ray or hormones. Now, why do they do this? I know, because I have questioned a lot o fthem. They refuse surgery because they have seen four or five cases of cancer in thir own family, and they have developed a cancer and

Confucius Say ...

The Chinese are recognized masters of soy bean cuisine. But they never eat soy bean products witthou first thoroughly soaking the beans, which is the secret of successful soy cookery. Here is a recipe for soy bean milk which illustrates the soaking process.

Soak soy beans in several changes of water in the refrigerator. This is to extract a water-soluble enzyme that blocks the digestion of the soy bean protein or any other protein eaten with it. (Bread made with untreated soy flour is often found "heavy on the stomach" and quite indigestible for some people.) Liquefy the soaked beans in a blendor and pour the cream into the bag of the juice press and extract the milk. This soy milk can be used for any purpose like ordinary milk.

The liquefied beans direct from the blendor can be used in bread making as 10% of the flour (in dry soy bean weight).

#### New Margarine Reduces Cholesterol Level

During the recent AMA convention in San Francisco a team of doctors from Central State Hospital in Indianapolis reported a new table margarine that will reduce the levels of cholesterol in the blood.

The margarine is made from non-hydrogenated corn oil and is rich in linoleic acid, the factor that helps rid the body of cholesterol.

When the margarine was used during a nine week test in pan frying, flavoring vegetables and as a spread on bread, the linoleic acid in the diet of the 301 test patients rose from 7 to 22 per cent.

#### Seeks the Truth

Morris A. Bealle, editor of Capsule News, the truth hunting weekly news digest published out of Washington, D. C., is on a six-week tour of 14 European countries seeking to find the truth about health systems in foreign lands.

One of the things he intends to investigate fully is the German health system. He has been informed that Germany is the most forward nation in the world on health matters, and that they—

they have outlived the patients who have been submitted to surgery, or, on the basis of their observations they claim that these people who have not been operated on or submitted to x-ray live longer than those who have. That is their impression. That is why they say this. I'm not saying that this is true or false; I'm telling you what I have observed."

(By way of background not brought forth by Ivy or others at this hearing, we may cite a comprehensive, though popularly ignored, study on the survival rates of cancer patients treated by surgery and/or radiation as contrasted to untreated patients. Professor Hardin B. Jones, of the University of California Medical School, on the basis of work supported by the U.S. Public Health Service, the Atomic Energy Commission, and the Guggenheim Foundation presented a paper before the New York Academy of Sciences in January 1956 on "Demographic Consideration of the Cancer Problem," reported in pages 298-333 of the Transactions of that society, Vol. 18, Ser. II, No. 4. Dr. Jones' concluding discussion in this lengthy statistical review includes the following remarks: "It has been suggested that the untreated cases are perhaps longer-lived than the treated cases, and the evidence is strong enough to warrant full attention to this part of the cancer problem, for not only is there complete uncertainty of the efficacy of cancer treatment today, but there is also the possibility that survival tendency is less with treatment. It is most likely that, in terms of life expectancy the chance of survival is no better with than without treatment, and there is the possibility that treatment may make the survival time of cancer cases less.")

Attitude Toward Organized Medicine. The tone of Dr. Ivy's testimony as it concerned the American Medical Association was one of scholarly if not objective restraint. In describing the official A.M.A. report on Krebiozen published in the Journal of the American Medical Association in October 1951, Ivy testified: "That's what I call superficial research. It was trumped-up research. The motives which caused this committee to trumpup this sort of evidence I do not know, and what I am telling you here under oath—I know that I'm under oath, and you don't have to tell me, because I have made this statement many times under oath, and, when presented, the evidence under oath has never been denied by any physician, by the one man who sent the American Medical Association these falsified cases at the prompting of the treasurer of the American Medical Association, not by any member of the American Medical Association."

More in sorrow than in anger, Dr. Ivy added: "It is a disgrace to a great and noble profession, to which Mrs. Ivy and I have contributed four sons. These reports should be corrected. The whole profession should be hanging their heads in shame to think that these reports have stood there and have not aroused the profession to condemn them."

It will be recalled that the Treasurer of the American Medical Association to whom Dr. Ivy refers is one Dr. J. J. Moore, whom Ivy elsewhere under oath accused of instigating a plot to ruin Krebiozen because of Ivy's refusal to sanc-

tion selling the rights in Krebiozen to a group in which Moore was interested. These charges have never, to our knowledge, been denied by Americal Medical Association; however, the continuing regard for the integrity of Dr. Ivy is manifest by the A.M.A. in the fact that several years after Ivy first made these charges the Journal of the American Medical Association, in a special issue on medical ethics (7 June 1958, p. 10), wrote of Ivy as an authority on medical ethics.

The Identity of Krebiozen. Twenty-four hours after Dr. Ivy presented his testimony, Professor Paul Kirk of the University of California and Dr. Arthur Furst of Stanford University were called to testify as to the chemical composition of samples of Krebiozen supplied them by the California Medical Association. Both of these chemists testified that Krebiozen was nothing more than plain mineral oil. This adverse testimony was given wide newspaper, radio and TV publicity while Dr. Ivy was returning from California and unavailable for defensive comment.

For this reason the following direct testimony from Dr. Ivy made BEFORE Doctors Kirk and Furst testified, and never mentioned by them nor in the associated news stories, is cited in fairness to Dr. Ivy: "In that connection it has been said that when you take an ampule of Krebiozen and extract it you can't find anything in it except mineral oil; that is because there is only a hundredth of a milligram there, ten micrograms present, and when we extracted Krebiozen from the mineral oil we used four thousand ampules."

It is believed that Doctors Kirk and IULY-AUGUST. 1958

Furst used fewer than half a dozen ampules of Krebiozen for their highly publicized story. In a letter dated June 20, 1958, to the Senate Interim Committee on Public Health, Dr. Ivy wrote: "Messrs. Kirk and Furst were either so misled by their negative microchemical findings, or so secure when protected against a suit for libel when testifying before a legislative committee that they did not consider categorical evidence exists to prove that a powder called Krebiozen was deliberately added to No. 9 Light Mineral Oil and stirred in thoroughly with an electric stirrer before it

"Both the testimony briefed by me under Section vii and by Messrs. Kirk and Furst under Section viii cannot be true . . ." Ivy pointed out. "In asking for and urging a determination of this question by Committee or Grand Jury action, I should like to add that I am sure the COMMITTEE did not intend to allow itself to depreciate a potentially valuable property by the use of the vicious and dastardly technic of the 'Big Lie'."

Pushing further, Ivy stated: "I ask and urge that . . . this be referred to the proper law enforcement agency of the State of California for a determination of the facts and presentation to a Grand Jury. If the Grand Jury should indict me I shall waive any immunity which protects a witness before a legislative committee and all rights obstructing extradition from the State of Illinois to the State of California."

Ivy the Man. The single characteristic of Dr. Andrew Conway Ivy that has impressed most observers, friend and foe alike, is the monumental integrity that cloaks the man. Fortified by brains and guts, this is an almost terrifying integrity in an age given to equivocation and expediency. As one listener commented to me during Ivy's testimony — "Ivy doesn't scare and he doesn't run." He is unashamedly a practicing American. "I am for the free choice of physician by a patient, and for the free choice by the physician of the treatment of that patient," he explained to the Committee.

He was explicit in his opposition to

what he called "an authoritarian committee making lists of what is good and what is bad in the practice of medicine, or in any other field of science or its application. We have had a good example of this insofar as our missile program is concerned," he said.

Speaking of such authoritarian committees, he pointed our further: "You don't get justice on the basis of scientific evidence, only on the basis of the opinion of experts, and the opinion of experts, in the history of medical science and science in general, has been notiriously bad."

His sense of honesty and fair play were amusingly illustrated as he described the consternation shown by certain official agencies when he suggested that they actually make an objective or truthful scientific study of the claims made by Harry Hoxsey. "And then when you tell the public," he explained, "what you have done they will realize that you have done what is right, and they will not rally to a persecuted underdog." Those to whom he made the proposal, Ivy added: "thought I was sort of off my rocker. Just like a lot of people today; if you show them the Declaration of Independence they'll read it and ask, 'What sort of a document is this?' About seventy per cent of the people in the United Stats will say it is a communist document."

\* \* \*

In a regimented age that has become cynical and weary and that has too often and too completely struck a compromise with truth and sought an appeasement

with evil, the few Ivys stand out as giants. His is an unwearying and unvielding courage born of intellectual power and integrity. The unthinking courage of blind or unquestioning faith or stupidity, having as much potential for harm as for good, is not his. His is a courage inspired by the demands of integrity imposed by a crystalline clear and incisive intellect. It is a brand of courage that runs counter to the ethical passivity and superstition-born mores that in all ages comprises the barnyard mores of the faceless mob bowing in unquestioning conformity to police, priest or public opinion.

Those listening to his testimony, and admonished by Chairman Thompson against spontaneous outbreaks of applause, sensed the magnitude of what was transpiring. Here was a man with nothing to gain and all to lose—power, prestige, recognition and economic security—fighting against the passive stupidity or ignorance of the world and the active or militant stupidity of a portion of his profession. Beyond the possibility of the tangible rewards of public or professional approbation, above the imaginary incentives of the Norsemen's valhalla or the Christians' heaven or the Moslems' paradise, we saw a man impelled by the dictates of a sense of duty and integrity that a lifetime in the service of science had given him.

In Doctor Ivy we saw the measure of moral soundness and sanity that, fortified by intelligence, represent the minimum requirement for any society that is to survive in this complex age. Upon the integrities of science and the scientific method—a method that exacts destruction from those failing to adhere with

exactitude to truth or reality—depend such things as the success of our missile program. One deviation from the integrity of a physical law; one factual compromise in an electronic circuit; or one corruptible technician can mean the difference between a missile that works and one that fails, and that difference could spell our survival.

In what transpired during Dr. Ivy's testimony one seemed to sense, in many ways, that a slowly awakening public opinion has at last become intolerant toward the hollow authoritarian pontifications and untruths fostered by certain groups to impose by legislative flat their dictates on a free people.

It is possible to get very disgusted with the supposedly good government of the U.S.A. when you read the food laws of some other countries. Take Germany, for example. Their food laws prohibit implanting of stilbestrol in poultry. In the U.S.A. it is allowed. It is publicly stated in the German food law that "the basic policy is to keep the so-called 'staple foods' as close to their 'natural' state as possible." In the U.S. legislators are much more prone to listen to the whining voices of chemical industrialists looking for new markets for their products.

#### Smoking Linked to Death Rate

WASHINGTON, June 25—Cigarette smokers among 200,000 U.S. veterans studied had a 58 per cent greater death rate than non-smokers over a period of several years, the Public Health Service said today in an official report. In general, the survey results supported previous statistical studies linking smoking to earlier death. The report will be presented Tuesday to the 7th International Cancer Congress in London.

In a letter to the United Press, Senator Haluska informs that press service that the Clinic is, in keeping with the law, treating people, regardless of what state they come from. This is good news to many cancer sufferers in other eastern states. Doctors Now Using Hoxsey Treatments

Californians will be pleased to learn that in Southern California two capable doctors are now using the Hoxsey treatment as part of their regular practice. (In our opinion, this is the way it should be used.)

One is Dr. Thelma Arthur, D.O., with offices at 211 West Colorado Street, Monrovia, California. The other is Dr. Francis Altig, D.O., (formerly with the Fremont Clinic on Melrose Ave., L. A.). Dr. Altig is opening his office at 1036 So. Alvarado St., Los Angeles, California.

Like Dr. Altig, Dr. Arthur also was connected with the Fremont Clinic in Los Angeles. Dr. Arthur has just recently returned from a visit to the Hoxsey Cancer Clinic at Portage, Pennsylvania.

Both Dr. Altig and Dr. Arthur intend to use other types of Chemotherapy, such as Koch, Krebiozen and Mucoriacin whenever such appears to be indicated.

It is to be hoped that doctors throughout the United States will more and more start using, in addition to their regular procedures, such other remedies as apparently bring results.

In spite of all that is being said against Harry Hoxsey there is a great deal of

merit in his remedies. Even his worst enemies have to admit that his remedy does cure external cancer in many cases, and that internal cancer responds to his treatment sufficiently to warrant its use by doctors, whose license allows for its administration.

are losing this latter freedom. Bureaucratic regulations and medical monopolies are rapidly depriving Americans of their Freedom in all matters relating to Health.

The National Health Federation has been established to combat this evil.

Voice of the People

The National Health Federation proposes to serve as the voice of the people in matters pertaining to health since it has a popular grass-roots origin. Speaking for its thousands of members in all walks of life, it will demand rigid standards of food inspection; it will demand honest and impartial interpretation and enforcement of pure food laws designed to actually protect the health; it will demand freedom in the choice of doctor and healing method; it will demand freedom of the doctor to use whatever methods of treatment he deems best within the scope of his license without dictation from his professional association; it will demand an honest investigation in the fields of the so-called incurable diseases with the view of developing effective methods of treatment.

Without Bias and Prejudice

Not being affiliated with any commercial enterprize or profession, it can speak and work without bias or prejudice. It is not organized to promote or to criticize the methods of treatment of any of the healing professions. It is, however, unalterably opposed to the attempts of any one profession to monopolize the

field of health and healing and in this connection often finds cause to criticize the American Medical Association, but such criticism is directed towards the A.M.A. as a political force. Such criticism does not constitute a criticism of the thousands of honest and conscientious medicine as a system of healing or of men and women who practice medicine.

For Protection of the Public

The Federation is in favor of whatever regulations are necessary for the protection of the health of the American people, but it is unalterably opposed to the use of such regulations in the interests of a few favored individuals or corporations and/or the use of such regulations to destroy honest competition in the field of health, or to deprive the people of freedom of choice in matters relating to health.

Favor Food and Drug Act Purpose

The Federation is heartily in favor of the purposes which motivated Harvey W. Wiley in securing the passage of the Food and Drug Act, but is violently opposed to the present maladministration of the Act and to present apparent attempts of Food and Drug officials to destroy all methods of healing except that which is represented by the American Medical Association. The foregoing applies to the Post Office Department and also to the Federal Trade Commission.

Stands Back of Honest Officials

The Federation is prepared to stand back of every government official who has the courage to stand against the wrongful use of governmental powers, or against the enactment of laws or regula-

tions not in the best interest of the sick folks of America. By the same token, it must oppose with all its might those government officials who, for a mess of economic or political pottage, sell the people's birthright to health freedom and use the powers of government for evil purposes..

The National Health Federation Believes
The National Health Federation believes the basic points for a Healing Arts
Act to be as follows:

- 1. The scope of practice of all practitioners should be based upon the philosophy of each particular system of healing and the educational qualifications of the practitioner.
- 2. That all states should recognize and license the practice of Allopathic medicine and surgery, Osteopathic medicine and surgery, Chiropractic medicine, and Naturopatthic medicine.
- 3. Each system of medicine should have its own examining, licensing and administrative board. The police power of investigation should not overlap from one board to the other. In other words, each profession should clean its own house.
- 4. In order to define adequately the various systems of medicine, namely: Osteopathic Medicine, Chiropractic Medicine, and Naturopathic Medicine, something must be and should be done which all of these years has never happened; Allopathic Medicine and surgery must be defined. Otherwise, how are the peace officers to know when one profession has stepped out of its scope of practice?

Therefore: Drugs should be defined as "any substance, oral, intramuscular or intraveinous, which would be poisonous, destructive to tissue or deleterious to the physiology of the human body."

5. Major surgery should be defined as "the entrance by surgical or mechanical means into any of the five body cavities, or a gross amputation."

Minor surgery should constitute all forms of surgical procedure other than that defined as Major Surgery in the foregoing paragraph.

- 6. The Osteopathic physician and surgeon should enjoy recognition of practice equal to that of the Allopathic physician and surgeon by reason of the fact that he is as well trained in medicine and surgery as the M.D., and in addition, has knowledge of osteopathic manipulation.
- 7. The scope of practice that the Chiropractic and the Naturopathic physicians should enjoy should be determined by the curriculum of their schools submitted for the purpose of showing how extensively and thoroughly they are trained.

#### Conclusion

We are very happy to give this information to this Committee because the National Health Federation is not opposed to the doctors of any sect, including the Allopaths, organizing for the protection of their own interests, but it is unalterably opposed to their using such organizations in the protection of their members to the detriment of the health and personal welfare of the public.

The Federation has stated previously that it is not opposed to the American Medical Association. But it is unalterably opposed to its continuing effort to destroy all phases of the healing art except its own.

The Federation is not opposed to the present system of building hospitals for

the use of the Allopathic doctors in the treating of their patients, but it is unalterably opposed to its continued domination of these hospitals and other medical facilities to the exclusion of other Allopaths on no grounds other than that they do not belong to the County Branch of the American Medical Association.

The National Health Federation is not opposed to each of the healing sects policing its own doctors to the end that the services of said doctors may at all times be in the best interests of the people.

The National Health Federation is not opposed to the State or Federal Government appropriating tax monies to be used in the training of individuals who are to minister to the health of the people, but it is unalterably opposed to the system now practiced which allocates all of such funds to the training of members of the Allopathic sect to the exclusion of the Osteopathic, Chiropractic and Naturopathic professions.

The National Health Federation is not opposed to the enactment of necessary regulations or the setting up of necessary Commissions where such are proven to be absolutely necessary, but it is unalterably opposed to such Commissions, which presumably are set up for the protection of the public in health matters, being dominated by members of the healing arts regardless of whether they belong to the Allopathic, Osteopathic, Chiropractic or Naturopathic sects. It is our firm conviction that such Boards should consist of laymen empowered to seek the advice of members of the healing professions when such advice is needed to arrive at a sound and just conclusion.

I want to assure this Committee and JULY-AUGUST, 1958

the public that the National Health Federation intends to take whatever action is necessary to remedy these situations.

It is the opinion of the officers of the National Health Federation, the evidence so far presented to this Committee, favors as a solution to the cancer quack control problem in California, the strengthening of present laws and the providing of sufficient additional help to adequately cope with the problem, rather than the appointment of a commission or board.

The National Health Federation is convinced that the appointment of a Board or a Commission to determine what a regularly licensed doctor can or cannot do would be a definite step toward state medicine, and would in the end restrict duly licensed doctors in their ministering to cancer victims to such an extent as to be detrimental to the sick folks of California. In this connection I would like to call your attention to a recent news item which graphically illustrates what happens when a state legislature attempts to legislate how a disease condition must be diagnosed and treated (Wasserman test). News item, showing legalized testing procedure to be wrong in 54% of cases. (Copy filed with Committee.)

On behalf of the National Health Federation I would like to further call to the attention of this Committee a news item which indicates that the American Medical Association—its California and County branches—are unions, pure and simple, interested primarily in the economical and social welfare of their members and thus should not be accepted without question as spokesmen for the best interests of the sick. (News item—Strike Against California Medical Plan.) This item proves the Medical Association uses the

same tactics as regular unions use. (Copy filed with Committee.)

I would like also at this time, on behalf of the National Health Federation, to again reiterate that the American Medical Association and its affiiliates through their accredation plan for hospitals and medical facilities absolutely control the activities of such institutions to the detriment of the sick people of America and we urge that this Committee give serious consideration to the evidence sustaining the viewpoint which will be presented during these hearings. It is our firm conviction that if the lawmakers of California could find a way to break the stranglehold now held by the medical unions on our institutions of healing and learning, many of our health problems would speedily be solved.

In closing—on behalf of the Board of Governors and the members of the National Health Federation, I desire to thank this Committee for the kindness and courtesy extended to us during this presentation.

#### Dangers in Use of Tranquilizing Drugs

Dickel, H. A. & Dixon, H. H., J.A.M.A. 163:422-426.

Among 8,200 patients who had been given tranquilizing drugs for anxiety, there were 1,700 cases in which serious problems were created in essentially normal people, and 827 instances where emotional illness was aggravated. There were allergic phenomena in 96 patients, general toxic effects in 78, habituation in 72, sever liver disturbances in 31, other severe symptoms in 97, and death in 4. Two of the deaths were suicides.

The drugs are valuable to a certain degree when used wisely, but the physician must inform himself well if he is to use these tranquilizers, or any drugs, wisely. He must reorient his thinking about the indications for, and the limitations of, these drugs.—Medical Digest, April 1957.
