

A MOTHER'S CONCERNS – AND FIRST DO NO HARM

The damage done by the MMR vaccine to my son!!

I am the mother of two boys, one of age 16 and the other age 14; and giving birth to them was the best thing that I ever did in my life without question! Like every parent, I always wanted to do what was best for my children. And this desire starts as soon as they are born! When my youngest boy was born, he was a healthy, 8-pound baby. Just as importantly, he was a normal delivery! In fact, I refused pain relief, as I did not want gas or drugs, so that it could be a totally natural delivery, without side effects of any drugs on my baby or me.

After the birth, I took my son home from hospital and he not only was a healthy, full-term baby but also an excellent feeder. He was a content baby, sleeping all night until 6 a.m. He was just perfect.

Watch Out for Falling Envelopes

It was around the time that he was three month's old that the vaccine letters started to come through my door with booklets attached telling me how important it was to vaccinate my baby. So, naturally I went to the clinic and had my son immunized with his hib (haemophilus influenza type B) vaccines – as I had already done with my oldest son. Of course, at the time, it seemed right for me to do what we were told would help our children!

After receiving this first vaccine, my son was still thriving and was like a dream baby. He just never seemed to have any issues whatsoever! Little could I have guessed as to what was to come.

My son was 15 months old – and already a veteran of nine vaccines at that tender, young age – when again the letter came through the door for my son to now have his MMR (Measles, Mumps and Rubella) vaccines. I remember just telling the nurse that my son was slightly feverish and asking her if the vaccine would cause it to get worse. I took my son home, but he was no longer himself. He was very aggressive and screaming a lot. He was shaking his head with temper and was so angry he didn't want me to hold him. I immediately felt something was wrong, so I called the doctor that night as my son was not breathing properly. In fact, he was coughing so much it was causing him to gag when I was feeding him. The doctor on call would not come out to see my child – he told me it was only a slight, normal reaction to having the MMR and by morning he would be fine. Boy, was he wrong!

At about 6 a.m., my husband got out of bed to check on our son, who was in a state that you only can describe as choking. He was desperately struggling to breathe, and we ended up rushing him to the Casualty Room at the hospital. He was admitted there and remained for nine days.

When my son came home from hospital, he hated being held. He hated all of his toys and he stopped speaking as he had lost words. Instead, he spent most of his time turning on taps and flushing toilets. This was not the world I had envisioned for my son.

A Mother Knows

I was the only one who knew there was a connection between the MMR and this now strange behavior. Everyone else tried to tell me I was over reacting, but I knew my gut instinct as a mother was not wrong and I knew my son was reacting to the MMR. He was no longer the happy, loving baby any more. Instead, he was angry, frustrated, and screaming his lungs out. He also started head banging walls and even the floor sometimes. It was the most disturbing and horrible experience I had had in my life, to watch my beautiful boy tormented, as he did not know how to be himself anymore.

By the age of two, my son had now been to the hospital eleven times, all in the space of six months with chronic breathing problems. Also, once as he had a reaction to a slice of cake he had eaten at his brother's birthday party. His whole face blew up, his eyes were closed, and he scratched his face – it was just awful. Before my very eyes, my child was getting worse. My husband planned a holiday to Disneyland Florida in the hope that maybe this might excite him and maybe bring our once-happy son back to his senses and true self. We made the trip and my oldest son had a ball with his father. I, on the other hand, had to nurse my child as he took croup on our second day in Florida and never

recovered from it until we went back home. My baby boy was still getting worse before my very eyes!!


Upon returning back home, I went again to my general practitioner and demanded answers. In fact, I had been advised to look for a batch number of the MMR vaccines, so I did. I was basically given the run-around – I was told the batch number could be found in the hospital medical records, so I went there only to be informed that it was at my general practitioner's. This went on and on, and I never did get the batch number.

Lessons Learned

My son was diagnosed with autistic spectrum disorder when he was three years old. I fought the whole system but failed. I got doors closed in my face – nobody wanted to know. My marriage ended, and I basically became a single parent, rearing two boys. I am very lucky to have had a great family, and my boys are very lucky to have a good dad and extended family. I firmly believe that the MMR vaccine caused my son to have these problems. Today, my son is 14 years old and is mainstream schooled. He is an extremely bright and quiet boy and has just the heart and soul of a very genuine and sincere young boy.
