In this Board Election, there are seven candidates for six positions for you to fill. With our 12-member Board of Governors, at least four positions must be up for election every year so that every three years you will have the opportunity to elect or reject each and every member of the board. This year we had some vacancies arise and under our NHF Bylaws those Board members who were appointed to their positions must run for election by our NHF membership; hence, we have six open seats this election cycle.

Please select **six** candidates **ONLY** by marking the box next to their name, or under “write in nominees” on the ballot you may enter up to six names. If you know qualified candidates for the Board of Governors, you may write in their names. **Do not exceed six votes total or your ballot will be disqualified.**

Please be aware that “write-in” votes will only be counted if the particular candidate is presently an NHF member in good standing.

All ballots must be signed and postmarked on or before January 18, 2021, in order to be counted. Please remember that, as always, all envelopes containing members’ votes are collected and delivered to the NHF’s Certified Public Accountant, who confidentially opens and counts all votes, reporting only the vote totals to the Board. # BIOGRAPHIES OF THE CANDIDATES FOR NHF BOARD OF GOVERNORS 2021



**DR. BRADFORD S. WEEKS, M.D. (Incumbent)**

Dr. Bradford Weeks is in his 25th year as the Founder and Medical Director of Whidbey Island, Washington-based “Alternative Health Advocates,” an educational and advocacy service for terminal patients interested in “corrective medicine and psychiatry” which identifies and corrects deficiencies and toxicities in the physical, etheric, emotional and spiritual spheres. Early work with venoms led him to a study in immunology, and in 1986 he founded and was president of the American Apitherapy Society, Inc. while editing the society journal “BeeWell.” In part, stemming from his mentorship under Dr. Abram Hoffer, M.D., Dr. Weeks’ contributions to health encompass pioneering therapies such as orthomolecular psychiatry and psycho-neuro-immunology, and he is one of only three U.S. doctors teaching insulin potentiation chemotherapy (IPT) and developing genetic repair protocols for cancer patients. He offers “centsible” (i.e., safe, effective and cost-efficient) therapeutic options for people facing life-threatening chronic degenerative diseases. He founded the Washington Integrative Medicine Association ([www.washima.org](http://www.washima.org)) to protect healthcare freedom in that State and currently serves as Vice-Chairman and Treasurer of the NHF Board of Governors. **DR. MURRAY “BUZ” SUSSER, M.D. DIPL (Incumbent)**

Dr. Susser has spent four decades pDr. Susser has spent four decades practicing Advanced Medicine and fighting for the right to do so. He was the fourth President of the American College for Advancement in Medicine (ACAM) and the third President of the American Association for Health Freedom (AAHF). He has devoted a great part of his professional and personal life to the causes that NHF espouses and is a long-time NHF member, supporter, and active member of the NHF Board of Governors. In doing so, Dr. Susser says that he has “had the privilege of working shoulder to shoulder with the NHF Board and many others from the past and many who are now the immediate future in our quest for the simple, but elusive, health freedom to which we are entitled.” As always, he welcomes the challenge and has confidence we will continue to win until we have final victory. **MICHAEL LEVESQUE (Incumbent)**

Since 1973, Michael Levesque has promoted and sold health foods and nutritional supplements

with his first store in Cortez, Colorado. In 1982, he opened Vitamin Express in San Francisco, focusing on nutritional supplements. In the early 1990s, he was an active participant in the struggle for

the recognition of nutritional supplements’ benefits and protection under the Dietary Supplement Health and Education Act (DSHEA), and of consumers’ rights to know how to protect their health and be informed of natural alternatives. In 2018, he “retired” and began RayGuardProtect.com, focusing on the most dangerous, life-threatening commercial movement facing us, the proliferation of electromagnetic field/radio frequency (EMF/RF) wireless transmission. Michael is currently an active member of the NHF Board of Governors, author of articles printed in Health Freedom News, and working keenly on the NHF campaign to protect us from 5G and other dangerous EMFs. Alex Landry has championed health freedom, mindfulness, nutrition, permaculture, social entrepreneurship, superfoods, urban farming, and yoga for over ten years. Alex has been the NHF’s video host over the past one year and recently started working closely with NHF’s lobbyist Charles Frohman on NHF campaigns to repeal the National Childhood Vaccine Injury Act (NCVIA) of 1986, and to pass legislation to prevent mandatory vaccinations. Earlier in 2020 Alex became a residential and commercial realtor, and in August, the Farm & Ranch director of Century 21-Coastal Alliance. Dr. Gary G. Kohls is a retired rural family physician from Duluth, Minnesota. For the past 12 years since his retirement in 2008, he has written a weekly column for the Reader Weekly, Duluth’s alternative newsweekly magazine. His column, titled “Duty to Warn,” has been re-published and archived at websites around the World. Dr. Kohls practiced holistic mental health care in Duluth for the last decade of his family practice career, primarily helping psychiatric patients who had become addicted to their cocktails of dangerous, addictive psychiatric drugs to safely go through the complex withdrawal process.
