Health Freedom Requires Informed Consent, Honest Science, and an End to Regulatory Capture

1. **No Vaccine Mandates, even during Emergencies.** Rep. Miller [needs your Rep's original cosponsorship](#)), for the Federal informed consent exemption bill, which also reports the results of Disease Outcome comparison studies between the vaccinated and the unvaxxed control group (which has never been done). Congress also should [restore](#) vaxx injury liability onto pHARMA and [repeal](#) the PREP act, which grants government during loosely-declared “emergencies” totalitarian powers and a license to commit crime without liability.
2. **Don't trade one threat to informed consent with another.** RFK's MAHA investigation of what's causing the real epidemic, chronic disease, [now includes](#) Electromagnetic Radiation, and [it's a lie](#) when Telecom – pushing tech “neutrality” – claims it's cheaper to use wireless for broadband connections. Before Congress floods our parks, farms, and towers with an unlimited number of additional antennas, FCC needs [to be forced to comply](#) with a 2021 court order to ensure safe exposure limits. Also, please push legislators to cosponsor Rep. Smith's HR 8082 to [restore](#) local antenna location discretion, and introduce legislation to [repeal](#) Telecom § 704 that shields Telecom from human injury liability.
3. **Stop farm poisoning.** Last Congress' [Farm bill](#) would have preempted local organic requirements, as well as weakened genetic-mutilation (GMO) labeling. More recently, States have sought [pesticide liability shields](#) now included in the Interior Appropriations bill. The EPA must apply European-like regulations on pesticides, and the USDA must cajole farmers to adopt regenerative practices.
4. **Stop persecuting natural health care.** Years ago, the FDA issued “[Guidance](#)” for both traditional homeopathy *and* compounding by pharmacists who use non-pHARMA ingredients. Both Guidelines have led to drug-like pre approval requirements for natural health treatments. Further, given public polling [support for](#) clear labeling, natural entrepreneurs need to be given back their Free Speech rights to tell consumers what the science says about their products – and crony corporations should not be allowed to use [misleading language](#) to hide toxins from the label.
5. **Don't sacrifice health to the weather-mutilating Climate Alarmists.** Using shoddy science, Climate cultists have been modifying the weather for decades, partly from jet exhaust for which EPA regulation was deemphasized in the 2021 “Federal Weather Enterprise” report. The Biden Administration proposed spending billions to pollute the atmosphere, inducing a daily haze that dims the Sun and aggravates chronic disease. Congress should immediately defund [geoengineering](#) and pass [Ms. Greene's bill](#).
6. **Respect patient privacy.** Whether [through](#) RFK's “wearables” promotion or the [Genius Act](#) that will unleash the Fed's central bank digital currency scheme, we oppose empowering the post-911 surveillance state. For years, legislators have defunded the Patient ID authorized in the HIPPA law. Stop any form of [Digital ID](#) that will lead to behavior coercion of dissidents not compliant with the narrative gatekeepers.
